

TERMS OF THE LEASE FOR VEHICLES WITHOUT DRIVER

Gali-rent a car, SL hiring the vehicle, subject to the terms and conditions of this contract, you acknowledge and agree that's true. It is our intention that all terms thereof are outlined here. Please read them carefully and if not returned or not satisfied at some points, let us know before accepting it.

TIME DURATION, DELIVERY AND RETURN

Gali-rent a car, gives SL an ideal vehicle for the purpose you want it, in overall good performance and without apparent damage otherwise recorded in the front of this contract, in the space provided. You agree to return it in the same state and are responsible for their proper use and must return at a date and time indicated in this contract, in the same condition in which it receives, including keys for normal usage, interior and exterior cleaning, fuel, trim, body, paint, tires, tools and accessories, except wear due to normal use. In the event that we return the vehicle under conditions that require substantial cleanup, Gali-rent a car, SL reserves the right to clean the vehicle (at your cost), prior to the inspection to take the vehicle for receptions and the rent and complete.

If you return the vehicle to observe the lack of documentation, compensate the lessee-Gali rent a car, SL, 60.10 € (10,000 pts.) Plus the cost of day protest forced the vehicle for that cause, the rental price. The minimum rental is for one day. The rental day consists of 24 hours counting from the start of the holiday. The refund shall be made in the same place of delivery unless specified on the front of this contract. When the rent is for periods of time without specifying date (weeks, months), completion of the contract will be, the same day he entered after that deadline, unless before the expiry of the term agreed, you apply for your extension and accept a car-rent Gali, SL, in which case would be given a new contract annexed to the force. The delay (delay exceeding 59 minutes) in the return of the vehicle shall cause the tenant, in addition to the enforceability of the price of the days of using a penalty of 30.05 € (5,000 pesetas.) Per day not specified in the contract. If you decide to return the vehicle before the date fixed, you assumed total of revenues remaining to be overcome. Only one considers that the vehicle has been returned when the keys are the same and its been delivered to a car-rent Gali, SL.

The duration of the contract shall be reduced prior to the date of our request. We can repossess the vehicle at any time without prior notice and at its own expense if the vehicle is used in breach of the provisions of this contract, if we believe on reasonable grounds that you have breached, or if it considers the possibility that not pay the final price of the rent or not proceed on schedule to return the vehicle or by circumstances such as designation of the address wrong or false move: refund of fees, if an agreed division of the rental price, design legal proceedings against the tenant, without incurring a car-rent Gali, Inc. be liable for the alleged damages and / or damages that may avail you.

The lost property, shall in no case responsible for a car-rent Gali, SL to take them away for three months after completion of the service, to be sent with postage due to its ownership claim case.

THE DRIVER

The driver you tell us for this contract and you provide the information required of it, meets the minimum requirements of being over age 25 years and driving license Minimum of two years. And hold throughout the period covered by this contract for driver's license, according to the characteristics of the vehicle to the notice.

RATES OF SETTLEMENT AND PAYMENT

You as a renter must pay a car-rent Gali, SL (credit card, without written permission of Gali-rent a car, SL to use other means):

- The charges for the rental vehicle that has been fixed in accordance with the current prices, excluding I.V.A. IGIC or fuel or equally responsible for the security and guarantees that are required prior to vehicle delivery.
- The charge for the mileage, at the rate specified for the mileage covered by said vehieulo during the term of this lease (determined by reading the odometer installed by the manufacturer, if the odometer would be spoiled or manipulate the Mileage daily minimum charge of 750 km
- The days of stay (not exploitation) of the vehicle by accident, breakdown or retention of the same by public bodies, due to the negligence of the lessee, as current rental rate.
- All charges under this contract and all court costs and reasonable attorneys' fees, incurred by claims of amounts owed by you as tenant to rent a car Galirent, Inc. as lessor.

Gali-rent a car, SL, request an authorization for an amount as security for payment obligations assumed by you to the card issuer before the start of the holiday.

The settlement of this contract and the charges you may be generated will be settled in time to start the car, in the currency and exchange-listed porGali rent a car, S. Ly to conclude on rent to make the final.

If the rental fee should go to a third party, either an insurance company or another, you as tenant will remain responsible for the settlement, unable to bind car-rent Gali, Inc. to charge the third party you designate .

VIOLATIONS OF TRAFFIC RULES

You assume full responsibility for any fines and other consequences of the infringement of traffic rules, or infringement of laws, regulations or ordinances that you must respond including failure to submit his request to the traffic officers of the documentation Mandatory vehicle that is given next to it. If a car-rent Gali, SL had to pay these fines, you agree that we may charge your credit card or charge during the term of the lease or returned after the vehieulo, the amount of the fine or fines for . A charge of 10% of the fine may also be charged to offset the administrative work that this requires, in the case of liquidating the fine prescribed in the event that a car-rent Gali SL present resources as required to identify the driver responsible for the offense which requires the owner of a vehicle in Article 72.3 of the Traffic Act (Royal Legislative Decree 339/1990 of 2 March) before the administration of receiving notice of termination.

INSURANCE, ACCIDENT

You as a renter and the driver authorized by this contract, participates as an insured of the benefits of Automobile Insurance Policy, a copy of which can be examined in the office of a car-rent Gali, Inc. This policy includes liability and damage to third parties. You as the lessee accepts the terms and conditions thereof, it being understood by you, which is a normal Policy Automobile Insurance in Spain. Such insurance does not cover loss or damage of luggage or goods or personal items also does not cover damage to wheels, tires or tires. Insurance does not cover the top of the vehicle body when it has collision damage, crash into trees, garage doors, bridges and against any other object, poor assessment of the height of the driver. In case of theft is not demonstrable return of the keys by You as a tenant, the tenant will pay the market value of the vehicle. In case of theft or fire, the tenant will pay the difference covered by the insurance policy and the market value of the vehicle. Each of the collisions are not attributable to a hand and covered by the insurance policy of vehieulo generates a charge to the tenant of 240.40 € For vehicles of categories B and 360.61 € for the category C, higher than the C or vans. We need to accept blame for the insurer of the opposing party, to our insurance company to access the return of or finance. Should the damage not be covered by the automobile insurance policy, you will not be tested before the insurance company of our vehicle is guilty of a third party for any serious damage by rental price usteu to the days until the incorporation of the vehicle in the same manner as was given.

In case of accident, you as tenant undertakes to:

- A) Get names and addresses of persons who have been involved in the accident as well as potential witnesses.
- B) Not admitting liability or guilt.
- C) Do not leave our vehicle without taking adequate measures to protect and safeguard it.
- D) Provide a detailed report by telephone to the nearest office of a car-rent Gali SL, as an immediate measure, and people within twenty-four hours in any establishment of the same, to deliver signed a corresponding part of accident or completed.
- E) Report immediately to the police it's guilt or otherwise should be investigated whether there were injuries.
- F) Attend a car-rent Gali SL and insurers to deal with proceedings in the Court, granted a permit to be processed in court proceedings on his behalf and defend any proceedings instituted against you.

DISABLE THE VEHICLE BY ACCIDENT OR BREAKDOWN

It is the duty of the driver stop the vehicle as soon as possible if still running, lights on the dashboard any witnesses that detect an abnormality of function or when perceived malfunction or breakdown. If deactivation of the vehicle shall deliver the same in the official service mark of the vehicle, closer to the event, through roadside assistance contract (and only with this one) for that vehicle. Within 24 hours we will report the incident. Gali-rent a car SL shall not charge the use of assistance which does not correspond to that provided for the vehicle.

BREAKDOWNS AND MAINTENANCE

You as the client undertakes specially to keep optimum water level of the radiator, preventing its evaporation or freezing, and the oil according to manufacturer's technical specifications, this maintenance will be paid to you at the end of the contract, with final settlement thereof, upon presentation of appropriate invoices containing the particulars of a car-rent Gali, SL, like any kind of repair and / or revision was due to en route, during the period of the contract, provided and when a car-rent Gali, SL had authorized that repair checking that has no origin in the misuse of the vehicle. Any part or item replaced vehicle will be delivered next to it.

TERMS OF USE

Should you care for your vehicle, its proper use, and protect it when not in use, use the right fuel, use of safety devices, not to transport live animals (except pets and / or pets, written permission of Gali - rent a car, SL) Do not smoke or allow smoking, notify the landlord prior to rental use and to carry dangerous goods must not allow the vehicle is used for:

- A) Carry passengers for money, or in excess of the limit indicated in the Technical Inspection Card of the vehicle.
- B) Transporting goods in passenger cars, or transporting people or goods, when this means explicitly or implicitly, the subleasing of the vehicle.
- C) To push or tow any other vehicle, trailer or object, like how to teach or to practice driving.
- D) To participate in races, radios, test or other competitions, including training and testing for competitive purposes, industrial or reactivity.
- E) Its use when the driver is under the influence of alcohol, drugs or any other substance that affects your consciousness or responsiveness.
- F) Failure of any rule or infringement of traffic laws, regulations or ordinances.
- G) His guidance, for any other driver other than that contained in this contract.
- H) To drive or be driven to or in countries that are not members of the EEC, including those authorized Andorra, Switzerland and Norway. In any case you need our prior written permission to travel outside the country where you rented the vehicle.
- I) To put to any use or illegal activities, including sublease the vehicle.
- J) To drive in restricted areas, airport runways, airport service roads and associated areas, war zones, military zones and tracks or sites which, by its poor road condition, could cause damage to the underside of the vehicle.
- K) To be transported in any type of boat, train, bus or plane (unless written permission from Gali-rent a car, SL)

Any breach of conditions on its part which could present to a car-rent Gali, SL a loss as to where the vehicle, both the period of operation and the integrity of the vehicle, you pose to explicitly take the days elapsed (such as rent, as fee) until the incorporation of the vehicle in the same manner as was given to a base Galirent a car, SL, and the responsibility for repairs, transportation, replacement, legal fees I approaches that Gali-rent a car, SL considers appropriate.
